

AGREEMENT

This agreement is made on _____ - between: -a

after called as **Party#1**]

AND

[herein after called as **Party-2**]

1. Affiliate Members are the "**Ambassador at Large**", who represent **FULUSQUE** in their areas of influence, and preach, extend as well as propagate our business principles and philosophy. **FULUSQUE** symbolizes loyalty and subservient to **Laws of the Land** and aims for providence to humanity.
2. **Party-2** has agreed to get Memberships of **FULUSQUE** and injected Rs. _____ /- (**Pak Rupees** _____ **only**) for _____ **years**, however, after one year **Party-2** has the right to **terminate this membership by rendering 3 months** prior written notice and **Party-1** has agreed to give **Party-2** the status of **Member of FULUSQUE, IN CONSIDERATION** of the Terms and Conditions mentioned in ensuing paragraphs.
3. That **Party-1**, in return of Rs. _____ /- (**Pak Rupees** _____ **only**) for _____ **years** injected amount as, will render favour money to **Party-2** ranging from Rs. _____ /- monthly (till the validity of this agreement) depending upon the earning.
4. That **Party-2** will **not claim to reimburse the Rs. Rs.** _____ /- (**Pak Rupees** _____ **only**) for _____ **years** membership fee **before minimum one year** or before termination of this agreement i.e. _____ **years**.
5. That after completion of 1 year, Rs. _____ /- (**Pak Rupees** _____ **only**) for _____ **years** the membership fee will be returned by **Party-1** to **Party-2** within three months.
6. That **Party-2** will **not ask for revision or increase** of the monthly favour money while this agreement is in vogue.
7. That **Party-1**, in case of non-existence of the **Party-2** during the validity of this agreement, is bound to pay the monthly favour money as mentioned at clause 3 above to the legal heirs of **Party-2** till completion of this agreement.
8. That **Party-2** is not authorized to make any agreement or contract at his own with any person or company unless approved by **FULUSQUE**.

9. That **Party-2** will neither demand nor get any cash on behalf of **FULUSQUE** from any person, company or organization and if found to be involved in any of such activities then **Party-1** has the right to take legal action against **Party-2**.

10. That **Party-2** will abide by the laws of the land and will not involve in any illegal activity which is likely to affect the reputation of **FULUSQUE**.

11. That **Party-1** will use this Membership Fee for operationalization / functioning and working of **FULUSQUE** which clearly reflects that favour money in return of the Membership Fee by **Party-1** is a rightful earning free from "**SOOD**".

12. That **Party-2** is to ensure safety and security of **FULUSQUE** information vis-à-vis policies, procedures and business principles.

13. Restrictions

a. **Validity.** This agreement is valid till one years of signing of this agreement, however, **minimum maturity period** for this agreement is **one year**. **Party-2** will not claim to reimburse **Rs. Rs.** _____/- (**Pak Rupees** _____ **only**) for _____ **years** , the Membership Fee, before one year or before termination of this agreement.

b. **Confidentiality of Information.** **Party-2** has joined **FULUSQUE** at his own free will and has been given this status based on trust and responsibility which makes **Party-2** privy to highly classified information about **FULUSQUE**. If **Party-2** decides to exit, the member shall leave with the undertaking to strictly keep confidentiality of the information. The Member defaulting on the confidentiality even after leaving **FULUSQUE** will be held responsible for any breach of trust proven against him/her.

c. **Termination.** Affiliate Membership may be terminated by **FULUSQUE** without assigning any reason on **1-month prior notice**. However, the termination by **FULUSQUE** will only take place on solid cognizant reasons, such as violation of the national laws of the state of residence. **The termination will culminate all perks and benefits agreed in above clauses** and the Membership Fee will be returned within **3 months**.

14. Both parties will read the contract carefully and no change in this agreement would be admissible unilaterally.

15. In case of any difference of opinion, the matter will be referred to a mutually agreed arbitrator, and the decision of arbitrator will be accepted by both the parties.

Both parties have read and understood this agreement and agreed to work together for successful accomplishment of future business ventures.
